Nomination Period Filing Extension
If nomination documents for an incumbent are not delivered by 5:00 p.m. on the 88th day before the primary election (December 8, 2023), any person other than the person who was the incumbent on the 88th day shall have until 5:00 p.m. on the 83rd day before the election (December 13, 2023) to file nomination documents for the elective office.
Public Examination Period
The Registrar of Voters shall make all nomination material available for public examination for a period of 10 calendar days immediately following the filing deadline. The public examination period shall commence on December 9, 2023 and continue through 5:00 p.m. on December 18, 2023. Public examination for offices with extended filing period shall begin on December 14, 2023 through December 23, 2023. Documents may be viewed at the Registrar of Voters' Office located at 940 West Main Street in El Centro.
