July 8, 2024 to Aug 7, 2024 E-120 to E-90	Registrar of Voters / District	Between these dates, the Registrar of Voters will publish a Notice of Election containing the date of the election, the offices to be filled, where nomination papers are available and the deadline for filing Declarations of Candidacy. The notice may be combined with the notice of identifying the central county place.

Aug. 9, 2024 E-88	District	Last day to consolidate with General Election. Resolutions from districts calling a measure are due to the Registrar of Voters by <b>August 9, 2024, 5:00 p.m.</b> If you wish to have a full text printed in the Voter Information Guide, the Registrar of Voters must have the full text by <b>August 9, 2024</b> . The statement of all measures submitted to the voters shall be abbreviated on the ballot and shall not contain more than 75 words. If applicable, all impartial analysis and fiscal impact statements are due by <b>August 9, 2024, 5:00 p.m.</b>

Aug. 9, 2024 E-88	District	Last day to file Tax Rate Statement for any bond measure appearing on the November 5, 2024 ballot.

Aug 10 - 19, 2024 E-87 to E-78	Registrar of Voters	Public Review period for the measure, text, impartial analysis, direct arguments and fiscal impact statement, if applicable.

File Rebuttals EC §9317, 9600		
Aug 22, 2024 E-75	District	Last day set by the Registrar of Voters for the same authors of the primary argument to file rebuttals with the Registrar of Voters. Rebuttals are limited to 250 words.
Public Review EC §9295		
Aug 23 to Sept 2, 2024 E-74 to E-64	Registrar of Voters	Public Review period for rebuttal arguments begins on <b>August 23, 2024</b> and closes <b>September 2, 2024</b> .

Nov 5, 2024 E-Day	Registrar of Voters	Polls open at 7:00 a.m. and will close at 8:00 p.m. Vote-by-Mail ballots may be turned in before the polls close at any polling place in the jurisdiction.
